HOPE staff annually trains all school Principals and co-administrators, school psychologists and support staff, school registrars, and school secretaries to ensure compliance with Federal and State Law and to promote the educational success of homeless students.

HOPE staff ensures compliance with CA Education Code related to homeless students. Posters are up at all MDUSD schools in English and Spanish regarding the rights of homeless students.

HOPE staff attends meetings related to academic, social and emotional adjustment of homeless students (i.e. Coordinated Care Team Meetings, SSTs, IEPs, 504 Plan Meetings, Discipline Hearings, Attendance Hearings, Elementary Case Conferences, etc.). Family needs are identified and addressed in collaboration with family, school, district and community programs.
